

Privacy Policy

Personally Identifiable Information

The Welcome Mat Ltd. collects personally identifiable information from you only with your knowledge and consent. The Welcome Mat Ltd. uses the services of two leading software companies for web scheduling, registration, order processing and online payments. Please visit their websites to acquire information about the companies and their Privacy Policies.

When you make a purchase through MindBody Online (our scheduling, booking and client management software), they ask for your name, address, phone number, email address and other personal information necessary to fulfill and track your order. For purposes of billing, you will need to provide your credit card type, number, expiration date and billing address for the card. MindBody also requires you to create an account by providing your email address and designating a unique access password for future access to your account information. Creating this account allows MindBody to save your billing information so you won't have to fill out that information again the next time you make a purchase on their site. For your privacy and security, credit card numbers are not stored in the MindBody system. Mindbodystores all data in servers and backup servers located in the United States. MINDBODY has Privacy Shield certification which complies with GDPR regulations related to transferring data outside of the EU.
